2020 BUDGET ADOPTION

WHEREAS, the Municipal Budget for 2020 was approved on the 23th day of March, 2020 and advertised in the Home News Tribune on March 31, 2020; and

WHEREAS, the Public Hearing on said budget advertised for April 27, 2020 was extended to May 11, 2020 and was held; and;

WHEREAS, the budget as approved required an amendment for the Current Fund to reflect changes made; and

WHEREAS, the amendments require a public hearing as the amendment includes decreases in items that exceed 10% of the item of appropriations, and grants that are new revenue and new appropriations per N.J.S.A. 40A:4-9; and

WHEREAS, the changes have no impact on property tax rate per N.J.S.A. 40A:4-9; and

WHEREAS, the Public Hearing on said budget amendment was held on the 28th day of May, 2020 and advertised in the Home News Tribune on May 16th and 19th, 2020; and
